THIS CERTIFICATE OF LIMITED PARTNERSHIP made this 23 day of March 1995, by and among CHARLES W. TOMLINSON, III of 1140 Lincoln Ct., Cape Coral, Florida 33904 (the "General Partner") and JANET TOMLINSON of 1140 Lincoln Ct., Cape Coral, Florida 33904 (the "Limited Partner").

**WITNESSETH:**

WHEREAS, the parties desire to form a limited partnership under the law of the State of Florida (the "Limited Partnership"); and

WHEREAS, the parties desire to set forth in writing the terms and conditions under which the Limited Partnership shall be operated.

NOW THEREFORE, the parties agree as follows:

1. Name. The name of the Limited Partnership shall be **Fisherman's Haldeman, LTD.**
2. Purpose. The Limited Partnership shall be formed for the sole purpose of acquiring, holding, owning, investing in, improving, operating, leasing, mortgaging and selling whatever property the Limited Partnership may acquire and to do all things related or incidental thereto, as permitted by law.
3. Location and Agent. The principal place of business of the Limited Partnership shall be 1140 Lincoln Ct., Cape Coral, Florida 33904. The agent for service of process for the Limited Partnership is Charles W. Tomlinson, III.

4. Partners. The name and address of the General Partner is as follows:

5. Term. The term for which the Limited Partnership shall exist shall begin as of the date first above written and shall end on December 31, 2025, unless earlier terminated.

6. Contributions. The amount of cash to be contributed by the Limited Partner is \$100. The Limited Partner has not agreed to make any further contributions.

7. Return of Contributions. The Limited Partner shall be entitled to the return of her contribution upon withdrawal from the Limited Partnership. The Limited Partner shall have no right to demand or receive property other than cash in return for his contribution.


8. Share of Profits, etc. The General Partner shall be entitled to receive 25% of all of the Limited Partnership's profits and losses. The Limited Partner shall be entitled to receive 75% of the Limited Partnership's profits and losses. The Limited Partner shall not be entitled to any other form of compensation from the Limited Partnership.

9. Transfer. The Limited Partner may not transfer, sell, alienate, assign or otherwise dispose of all or any part of her partnership interest whether voluntarily, involuntarily or by operation of law or at judicial sale without first obtaining the permission of the General Partner. A transferee or assignee of a limited partnership interest may be

admitted as a substitute limited partner only with the consent of the General Partner, which consent may be unreasonably withheld. The General Partner is authorized in its sole discretion to admit additional Limited Partners on such terms and for such contributions as the General Partner shall determine.



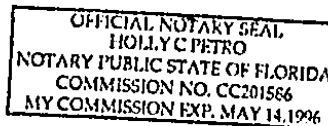

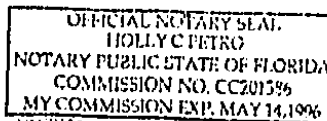
