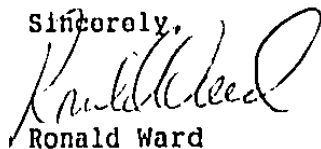

Article VI "Transfer of Partnership Interest" is being amended as follows:

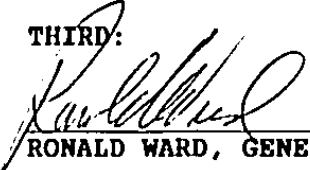
1. 29% interest held by J.P. Ward is being transferred to Noleka V. Ward, thereby deleting the interest held by J.P. Ward to 0%.
