Certificate of Amendment

1. Name. The name of the limited partnership is R & K Bateman, Ltd.

2. Original Certificate. The Certificate of Limited Partnership was filed on April 14th, 1995.

3. Amendment. The Certificate of Limited Partnership is amended to extend the term of the Partnership by deleting Section 6 of the Certificate in its entirety and substituting in its place the following:

6. Latest Dissolution Date. The latest date upon which the Partnership is to dissolve is March 31, 2035.

4.3 If, after the execution of this Certificate, the General Partner knows that any arrangement or other fact described in this Certificate has changed, making the statement inaccurate in any material respect, the General Partner will forthwith cause this Certificate to be canceled or amended, or file a petition for its cancellation or amendment pursuant to the Act.
