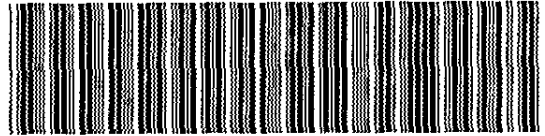

B. ARTICLE V, MANAGEMENT, Section 5.8 Compensation of General Partner, shall now be Section 5.7.


3. CONFIRMATION.


