**FIRST AMENDMENT TO**  
**FOUR J FAMILY LIMITED PARTNERSHIP**

THIS AMENDMENT, made effective as of the 2nd day of October, 1999, is the First Amendment to the Limited Partnership Agreement dated June 10, 1995 (the "Partnership Agreement") for FOUR J FAMILY LIMITED PARTNERSHIP, a Florida Limited Partnership (the "Partnership"), and is by and among BETTY JANE BARISH, as "General Partner", and JULIUS FRANK BARISH and BETTY JULI BARISH, as "Limited Partners".

**WITNESSETH:**

WHEREAS, the Partnership was formed pursuant to a Certificate of Limited Partnership filed with the office of the Secretary of State of Florida on the 14 day June, 1995; and

WHEREAS, the purpose of this Amendment is to provide for the change of general partnership interests in the Partnership.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree to the amendments to the Partnership Agreement which are set forth below.

1. RECITALS. The recitals set forth above are true and correct and are incorporated herein by this reference.

2. EFFECT OF AMENDMENT. Except as provided in this Amendment, the terms and conditions of the Partnership Agreement are hereby incorporated into this Amendment by this reference, the same as if fully set forth herein, except that in the

event of a conflict between the provisions of this Amendment and the Partnership Agreement, the provisions of this Amendment shall prevail.

3. LIMITED PARTNERS ACKNOWLEDGMENT AND CONSENT. Pursuant to the Agreement of Limited Partnership of FOUR J FAMILY LIMITED PARTNERSHIP, the undersigned Limited Partners hereby acknowledge the transfer of general partnership interest in the Partnership, and consent to the admission of this General Partner as substituted General Partner with respect to this additional general partnership interest.

4. SHARING OF NET PROFITS AND LOSSES. In recognition of the change of general partnership interests in the Partnership, Schedule "A", Schedule of Partners, of the Partnership Agreement shall be deleted in its entirety, and the following shall be inserted in its place:


