1. The name of the partnership is Peter & Pilot, LTD.
2. The partnership shall engage in the business of acquiring, outfitting and leasing to the General Partner a motor coach, or coaches, and other motor vehicles to be acquired by the partnership.
3. The principal place of business of the partnership is 31017 Airway Road, Leesburg, Lake County, Florida 34748. The mailing address is the same.
4. The name and address of each General Partner is:

5. The partnership commences upon filing of this Certificate with the Department of State, State of Florida, and shall continue until dissolved in some manner provided by law, or by agreement of the partners, but in no event later than December 31, 2010.

9. Upon the dissolution, or withdrawal of the General Partner, the Limited Partners have the right to carry on the partnership under the same name if one of them, or a third person agreed upon, assumes the status of General Partner.

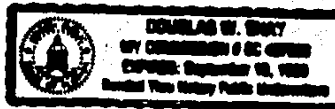

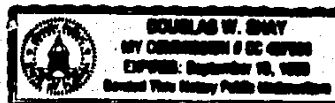
