4. In the event of the death of Roger L. Edwards, Janet L. Edwards shall become the Successor General Partner. In the event of the death of both Roger L. Edwards and Janet L. Edwards, Sue Ellen Kennedy shall serve as Successor General Partner for the sole purpose of winding up the affairs of RJE Investments, Ltd. The Successor General Partner shall distribute the assets of RJE

Investments, Ltd., to the then acting Trustee of the Roger Lee Edwards and Janet Lee Edwards AB Living Trust dated January 4, 2002. 5. In the event that Sue Ellen Kennedy shall be unable to serve as Successor General Partner, then William Patterson Edwards shall serve as said Successor General Partner.

6. Neither Sue Ellen Kennedy nor William Patterson Edwards shall personally have a monetary interest in the assets of RJE Investments, Ltd., but rather shall act as a fiduciary for the purpose of winding up the affairs of RJE Investments, Ltd as aforesaid.
