 - (i) International Investments of Tampa, Inc. withdraws as general partner.

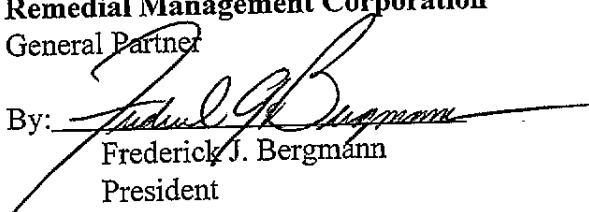
 - (ii) Remedial Management Corporation is admitted as a general partner of the Partnership pursuant to F.S. 620.123. / 794000059319
