This first amendment to the Amended and Restated Agreement of Limited Partnership ("Agreement"), dated January 6, 2006 by and among Frenchman's Resort Corporation, a Florida corporation ("FRC"), John C. Solomon, II ("JCSolomon") and Raymond E. Graziotto ("Graziotto"), such execution to evidence the mutual agreement of the parties to modify that Agreement, for the purposes and upon the terms and conditions hereinafter set forth.

WITNESSETH:

WHEREAS on January 6, 2006 the Limited Partnership interests of Marina Land Corporation were acquired by Graziotto and JCSolomon such that following that transaction the interests were held as follows;

Frenchman's Resort Corporation	1.000%
Raymond E. Graziotto	49.955%
John C Solomon, II	49.045%

and

WHEREAS on March 1, 2006, JCSolomon applied to transfer 5.000% of his 49.045% limited partner interest to his spouse Elizabeth A. Solomon ("EASolomon"); and

WHEREAS on that same March 1, 2006 Graziotto and JCSolomon agreed to each transfer a 0.500% limited partner interest to their jointly owned Frenchman's Marina, Inc. ("FMI") a Florida corporation registered under subchapter S of the Internal Revenue Code; and

WHERAS on that same March 1, 2006 Frenchman's Resort Corp. tendered its resignation to serve as the Partnership's General Partner and Frenchman's Marina, Inc. was elected to serve as the Partnership's successor POSOONONS General Partner, pursuant to Section 5 of the Amended and Restated Partnership Agreement, without any break that might otherwise trigger an event of Termination or Dissolution to the Partnership; and
