5. If not dissolved sooner by unanimous vote of the General Partners, this limited partnership shall dissolve December 31, 2045.

6. A. This limited partnership is formed to accept capital contributions from the Great-Grandchildren of Ruth S. Wedgworth, for the investment of such capital and the re-distribution of such capital and earnings to limited partners for their educational needs. A Great-Grandchild of Ruth S. C. The General Partners shall annually distribute to all limited partners no less than twenty-five percent (25%) of the earnings of the limited partnership from their accounts.

D. A limited partner whose account has been paid out in full, shall no longer be a limited partner of the limited partnership.

E. Any Great-Grandchild Limited Partner who has graduated with a degree from an institution of higher learning acceptable to a majority of the general partners and who requests pay-out or who remains a limited partner when he or she has attained the age of thirty (30) years shall be paid his or her account in full and shall no longer be a limited partner.
