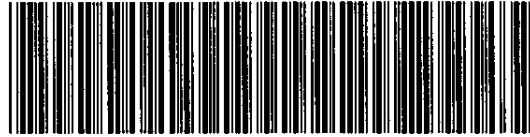

As you discussed with my grandson and attorney, Ben Brauser, I would like to reinstate the Company (Document #A95000001582) (the "Reinstatement"). 

