Gentlemen:

I am working with C. Michael Spero, Esquire, of Christy & Viener, 620 Fifth Avenue, New York, NY 10020, who represents the referenced partnership.

Enclosed for filing is the executed Application for Reinstatement for Limited Partnership and a check for \$1,041.25 which is submitted <u>under protest</u> in payment of the (i) \$437.50 maximum filing fee, (ii) \$103.75 supplemental fee for 1997 <u>being protested</u>, and (iii) \$500 penalty for 1997 <u>also being protested</u>, along with a second check for \$8.75 to cover the cost of a Certificate of Status.

We have made telephone calls to your office in an attempt to determine the reason for the general partner, Jeanne Shinefield, never receiving the first notice. The last conversation with your office was with Kenny on August 21, 1997, who advised he would pull the file to see what happened because the records do not reflect the New York mailing address and then call me to advise. Unfortunately, I still have not received a return telephone call.

Your office informed me that 2 notices were sent to the address of the principal office, 1111 Crandon Boulevard, Apt. B301, Key Biscayne, FL 33149. Mrs. Shinefield, who is extremely prompt and efficient, never received the first two notices. Furthermore, the 1996 Annual Report, a copy of which is enclosed for your convenient reference, reflects not only (i) the mailing address of "c/o Wien, Malkin & Bettex/Attn: C.M. Spero, 60 East 42nd Street, New York, NY 10165", but also (ii) the new mailing address of "c/o C. Michael Spero, 1165 Park Avenue, New York, NY 10128; yet notices were not sent to either mailing address on the 1996 Annual Report.

Accordingly, we believe these circumstances more than qualify for an exception to your general rule against waiver or abatement of the supplemental fees and penalty as a result of late filing. We, therefore, request your review of this file and issuance of a \$603.75 refund representing abatement of the supplemental fee and penalty.
