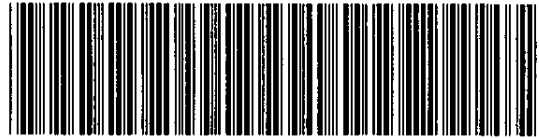

TO HAVE AND TO HOLD the same unto the Assignees forever, free from any and all liens and encumbrances.

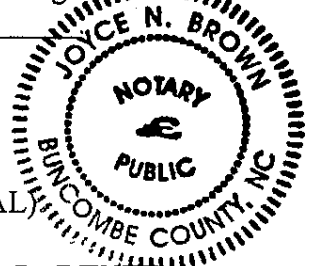
