

5. The partners of the Limited Partnership shall make capital contributions to the Limited Partnership as set forth in Exhibit A.



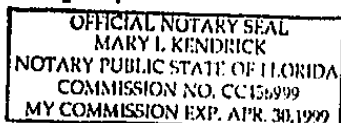
