

2. The certificate of limited partnership for del Rivero Messianu Advertising Limited was filed with the Secretary of State of the State of Florida on February 7, 1996.


3. The limited partnership has been dissolved as a result of the acquisition of all the limited partnership interests in the partnership by the general partner.
