
The undersigned, desiring to form a limited partnership under the laws of the State of Florida, does hereby certify as follows:



BEFORE ME, the undersigned authority personally appeared Edward E. Burr, who being first duly sworn, declared as follows:


1. He is the President of San Pablo Court, Inc., a Florida corporation and the general partner of San Pablo Court Partners, Ltd., a Florida limited partnership.

3. It is anticipated that the limited partners will contribute an additional \$900.00 to the partnership on or prior to December 31, 1996.

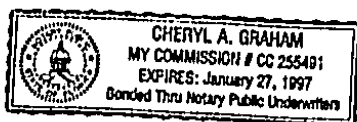
