

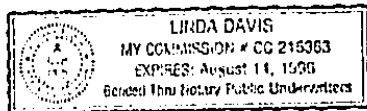
1. He is the president of AJS Management Corp., a Florida corporation, which is the general partner of Naples Warehouse, Ltd., a Florida limited partnership.

3. There are no further capital contributions anticipated from the limited partners.


