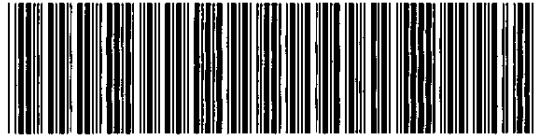




- A. Name of Limited Partnership. The name of the Limited Partnership is GDA Investments, LLLP.
