CERTIFICATE OF LIMITED PARTNERSHIP
for
A LOAF AFFAIR, LTD.

THIS AGREEMENT of Limited Partnership made this 5th day of January, 1996, by and between M. J. BURGESS, JR., 2248 First Street, Fort Myers, Florida, 33901, as General Partner.

WHEREAS, the parties wish to avail themselves of the benefits of the Uniform Limited Partnership Law of Florida in order to acquire, construct and lease as an investment and have agreed to do so as a Limited Partnership.

1. NAME OF PARTNERSHIP. The name of the partnership shall be A LOAF AFFAIR, LTD., hereinafter referred to as Partnership.
2. BUSINESS OF PARTNERSHIP. The Partnership shall be for the purpose of acquiring, constructing and leasing a building as an investment and in such other related businesses as may be necessary or proper in order to carry out the above purposes.
3. MAILING ADDRESS. The mailing address for the partnership shall be Post Office box 1503, Fort Myers, Florida, 33902.






