Dear Ms. Diane Cushing:

In response to your Sept. 29<sup>th</sup> letter (see copy attached), we feel that there has been some confusion regarding the renewal status of our Limited Partnership with the state and feel that the potential revocation of our status and fees due are unfair and unnecessary for the following reasons:

- 1- We did not receive the 1<sup>st</sup> notice of renewal in January of this year as we have done so in the past, due to address problems and mail returns beyond our control with the local postmaster.
- 2- Upon receipt of your second request notice, which was received by our office in delay due to the mail problems, we sent out the uniform business report on 9-16-03 which was received by your office on 9-19-03 (see attached copy of postmaster receipt notice and second notice cover page with filing request by September 24, 2003). The cover on this 2<sup>nd</sup> notice indicated if we did not file timely there would only be a fee of \$100 not \$400. When your office received application our renewal fees of \$141.25, they were kept and deposited to the state. If the intent was to revoke our company, the check we submitted should have been returned to us indicating that you would not accept the renewal without the appropriate fees due. By accepting the check we assumed that we were renewed.
- 3- Understanding the severity of the matter, we even tried to renew on line by going to sunbiz.org, but there were no clear instructions on where to file on the site.
- 4- Subsequent to the receipt of this letter we notified your office of our concerns by telephones and they requested that we write you explaining our position. We have now received another letter dated 10-03-03 (see copy attached) indicating that more fees will be accessed and our status has been revoked. We barley had an opportunity to respond the first letter.

In closing we would like to request that the fees be waived and a special exeption be made given the circumstances listed above and that we have been a member in good standing with the state of Florida since 1996.

Please respond as soon as possible so as to expedite the resolve of this matter.
