6. Paragraph 5 of the Certificate is hereby deleted in its entirety and the following substituted in lieu thereof:

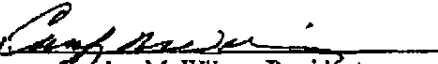
"5. The latest date upon which the Partnership is to dissolve shall be December 31, 2061."
