2. CHARACTER OF BUSINESS: The character of the business of the partnership is

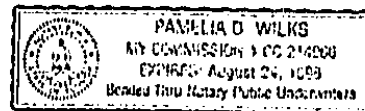

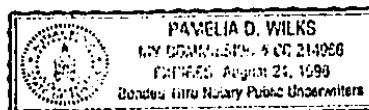
