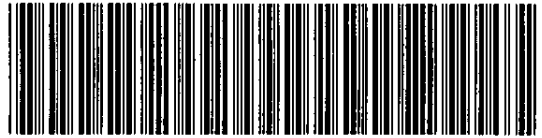

**THIRD:** Reason for Dissolution:


