**CERTIFICATE OF AMENDMENT  
TO CERTIFICATE OF LIMITED PARTNERSHIP

This Amendment to the Certificate is hereby signed by the new General Partner and former General Partner of the Partnership as of this 16<sup>th</sup> day of November, 2016.


