KNOW THAT Leonard E. Lewis, having a business address of 1310 Gulf Blvd, Clearwater, Fl 34630, hereinafter referred to as the "General Partner"

DOES CERTIFY THAT:

- I A certain Partnership known as the LEONARD E. LEWIS FAMILY PARTNERSHIP LTD., has been established for the purposes contained in the Partnership Agreement. The Partnership date shall be established as herein stated.
- II The Partnership shall be known as the LEONARD E. LEWIS FAMILY PARTNERSHIP LTD.
- III. The effective date of the Partnership shall be the date of filing with the Florida Department of State, Bureau of Commercial Recording, Division of Corporations, or any later date as the General Partner may deem appropriate, but not later than 90 days after filing with the Florida Department of State.
- IV. The General Partner of the LEONARD E. LEWIS FAMILY PARTNERSHIP LTD. is Leonard E. Lewis, whose address is 1310 Gulf Blvd, Clearwater, Fl. 34630.
- V The Registered Agent is WILLIAM DEMORROW, having a business address of 18167 U.S. Hwy 19 N, Suite 195, Clearwater, Fl. 34624.
- VI. The Partnership mailing address is 1310 Gulf Blvd, Clearwater, Fl. 34630.
- VII. The Partnership principal place of business is 1310 Gulf Blvd, Clearwater, Fl. 34630.
- VIII.
