



Our firm represents the above-referenced client. On March 18, 1997 our firm attempted to file a Certificate of Amendment to Application for Registration of Annabelle's Ltd. of North Florida, a copy of which is attached hereto as Exhibit "A". We enclosed our firm check in the amount of \$35.00 to cover the filing fee.

By letter dated March 26, 1997 the Certificate of Amendment was returned to our office along with a Limited Partnership Annual Report and a request for an additional \$17.50 for filing fees. My secretary immediately contacted someone in your office and was told the Limited Partnership Annual Report which reflected the decrease in capital contributions must be filed together with the Certificate of Amendment.
