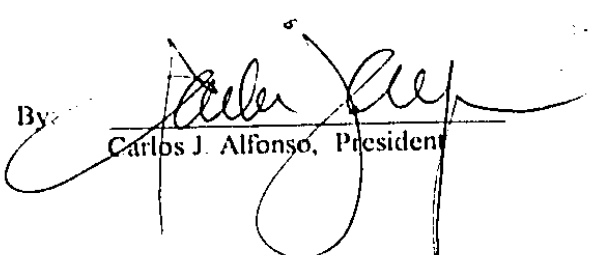

"1. Name. The name of the limited partnership shall be:

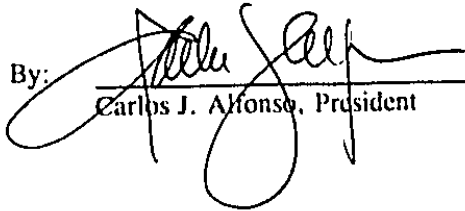
