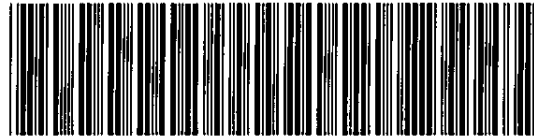

FIRST: The amendments to the certificate of limited partnership are:


1. The name of the Partnership is changed from Sample 95 Associates, Ltd. to Sample 95 Associates, Ltd. LLLP.
