## Dear Mr. Kassees:

I am sorry to have to bother you with this problem, but I have been unable to have your employees respond to what should be trivial housekeeping matters.

Starting two years ago, I notified your offices of two <u>new addresses</u> for the Principal Office of CBG Biotech, and for it's Mailing Address. These changes were written into the appropriate spaces of the Annual Report. A copy of last year's Report is attached for your reference.
