The undersigned, desiring to form a limited partnership under the laws of the State of Florida, do hereby certify as follows:


1. The name of the limited partnership is Horne Laurel, Ltd.



2. The capital contributions to said limited partnership as of the date hereof total \$2,000.00.

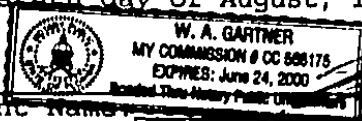
