2. No additional capital contributions are anticipated to be contributed by the limited partners in excess of the amount set forth in Paragraph 1, above, at this time.

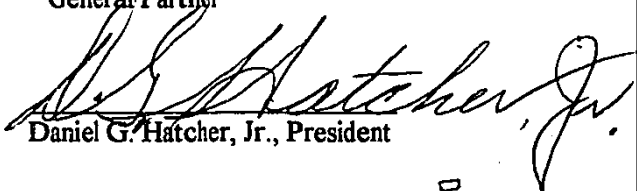
