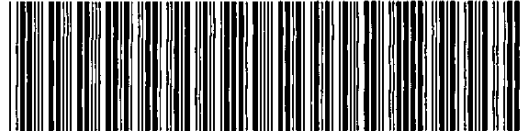


1. The name of the limited partnership is ZOM Gateway, Ltd. (the "Partnership").
