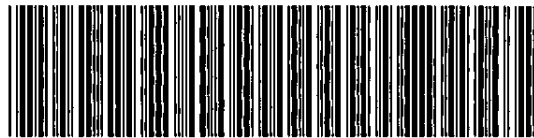

The purpose of this letter is to provide you with necessary information to correct or amend the previous filing dated July 3, 2008 and executed by Leslie Sellers. In summary and attached for your use, we filed a Certificate of Amendment to Certificate of Limited Partnership of Charlie N. Long, Jr. and Edna G. Long Family Limited Partnership (FLP) to remove Edna G. Long as a General Partner due to her death on December 20, 2007 and to remove Kenneth C. (Christopher) Long as a General Partner. Kenneth C. (Christopher) Long was added as General Partner in error in 2005 due to a misunderstanding with interpretation of Division of Corporation. Kenneth Christopher Long alias Chris Long is the General Manager of the FLP and is a limited partner, not a general partner. The July 3, 2008 filing indicates Kenneth C. Long and Kenneth Christopher Long (one and the same person) as a General Partner, which is in error. The Division of Motor Vehicles (DMV) Compliance Officer has brought this error to our attention as our Mobile Home Dealer Renewal Application was not re-issued until the Division of Corporation filing is corrected.
