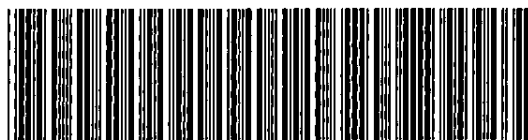

CERTIFICATE OF AMENDMENT
OF THE CERTIFICATE OF LIMITED PARTNERSHIP
OF FGG FLORIDA PARTNERSHIP, LTD.
A FLORIDA LIMITED PARTNERSHIP

The undersigned withdrawing and replacement General Partners, desiring to amend the Certificate of Limited Partnership filed pursuant to the Florida Revised Uniform Limited Partnership Act, as set forth in Chapter 620, Part I of the Florida Statutes (the "Act"), hereby state the following:

FIRST: The name of the limited partnership is **FGG FLORIDA PARTNERSHIP, LTD** (the "Partnership").

SECOND: The date of the filing of its Certificate of Limited Partnership under the Act (the "Certificate") was November 15, 1996.

THIRD: Paragraph 4 of the Certificate is hereby amended to change the identity of the general partner of the Partnership, effective as of March 22, 2012. Paragraph 4 of the Certificate shall henceforth read as follows:

4. The name and address of the General Partner is:

FOURTH: Paragraph 6 of the Certificate is hereby amended to extend the maximum duration of the Partnership. Paragraph 6 of the Certificate shall henceforth read as follows:

6. The latest date upon which the limited partnership shall dissolve is December 31, 2050.

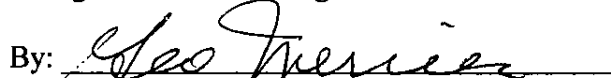
