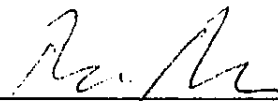
As Ricker Limited Partnership is an asset of probate, Robert M. Ricker has the authority to sign on behalf of the Estate and the deceased General Partner.

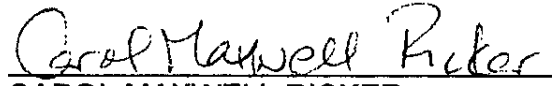
