**AMENDMENT TO
CERTIFICATE OF LIMITED PARTNERSHIP OF

V. TERM OF LIMITED PARTNERSHIP

The term for which the partnership is to exist begins upon the date the Certificate of Limited Partnership is initially filed with the Secretary of State of the State of Florida and shall continue in perpetuity, unless sooner terminated by law, the filing of a Certificate of Cancellation or under the provisions of the Agreement of Limited Partnership.
