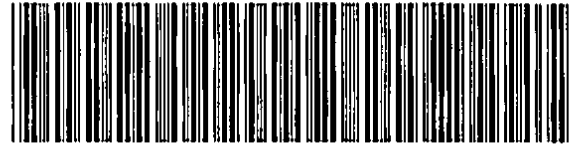




1. The name of the limited partnership is **J.M. FAMILY REAL ESTATE PARTNERS, LTD.** (hereinafter, the "Company").


