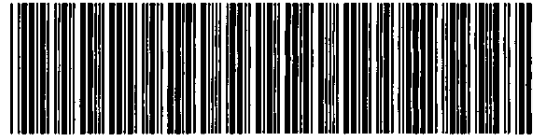



**AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF THE

Pursuant to the provisions of Section 620.1202, Florida Statutes (2006), the Florida Limited Partnership known as The Margaret W. Paul Family Limited Partnership amends and restates its Certificate of Limited Partnership to read as follows:

1. The name of the limited partnership is The Margaret W. Paul Family Limited Partnership. The Partnership's Certificate of Limited Partnership was filed on December 19, 1996. Amended and Restated Certificates of Limited Partnership were filed on January 6, 2006, and on February 8, 2007.

7. This Amended and Restated Certificate of Limited Partnership has been executed and is being filed to reflect the fact that Eugene S. Paul is the partnership's sole general partner.
