



SECOND AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP OF THE MARGARET W. PAUL FAMILY LIMITED PARTNERSHIP

Pursuant to the provisions of Sections 620.1202, Florida Statutes, the Florida limited partnership known as The Margaret W. Paul Family Limited Partnership amends and restates its Certificate of Limited Partnership to read as follows:
