**FIRST AMENDED AND RESTATED CERTIFICATE OF LIMITED PARTNERSHIP**  
**WALDREP ENTERPRISES, LLLP**

The general partners of Waldrep Enterprises, Ltd. submit this First Amended and Restated Certificate of Limited Partnership to evidence that the limited partnership has (i) admitted substitute general partners, (ii) elected limited liability limited partnership status, and (iii) changed its name to Waldrep Enterprises, LLLP.
