PLAN OF MERGER OF MED PLAZA, LLC, AND MED PLAZA II, LLC, WITH AND INTO FIRST STREET ASSOCIATES, LTD.

Med Plaza, LLC, a Florida member-managed limited liability company, Med Plaza II, LLC, a Florida member-managed limited liability company, and First Street Associates, Ltd., a Florida limited partnership, hereby adopt and approve the following plan as the Plan of Merger required by Sections 608.438 and 620,2106, Florida Statutes. The terms of the plan are as follows:

- 1. The names of the business entities planning to merge are Med Plaza, LLC, a Florida member-managed limited liability company ("Med Plaza"), Med Plaza II, LLC, a Florida member-managed limited liability company ("Med Plaza II"), and First Street Associates, Ltd., a Florida limited partnership ("First Street").
