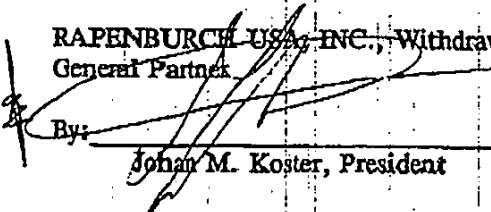
1. The name of the Partnership is GROSSE POINTE ASSOCIATES, LTD.

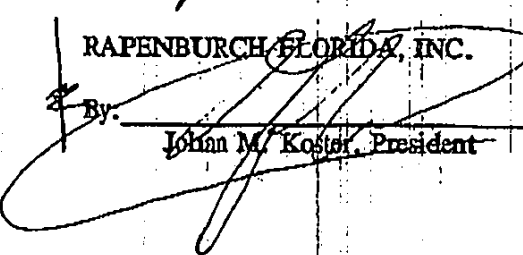
