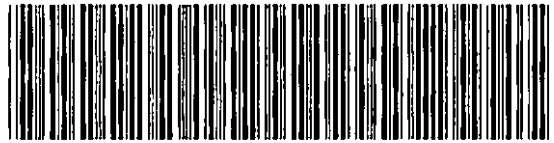


Both the general partners Forbes F Davis and Nan S Davis are deceased.
