4. The cancellation of the Partnership shall be effective upon the filing of the Certificate of Cancellation.

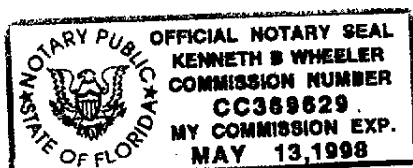
