ARTICLES OF MERGER OF LIMITED PARTNERSHIPS THE KREMSER FAMILY LIMITED PARTNERSHIP NORTH INTO THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH

Pursuant to Florida Statues Section 620.201 through 620.205, KREMSER MANAGEMENT, INC. as General Partner of KREMSER FAMILY LIMITED PARTNERSHIP formerly known as THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH sets forth as follows:

- 1. THE KREMSER FAMILY LIMITED PARTNERSHIP NORTH, a A9700000478
 Florida Limited Partnership, has agreed to merge with THE KREMSER FAMILY
 LIMITED PARTNERSHIP SOUTH, a Florida Limited Partnership. All of the assets of
 THE KREMSER FAMILY LIMITED PARTNERSHIP NORTH shall be transferred to
 and become an asset of THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH. A97000 0004
 All of the outstanding liabilities of THE KREMSER FAMILY LIMITED
 PARTNERSHIP NORTH shall be and are assumed by THE KREMSER FAMILY
 LIMITED PARTNERSHIP SOUTH. The Limited Partners of both partnerships
 participating in this merger are the same owning the same interest in both Partnerships.
 All existing Limited Partners in THE KREMSER FAMILY LIMITED PARTNERSHIP
 SOUTH and THE KREMSER FAMILY LIMITED PARTNERSHIP NORTH shall retain
 their same interests in the merged Limited Partnership.
- 2. KREMSER WRIGHT RD., INC. is the General Partner of THE KREMSER FAMILY LIMITED PARTNERSHIP NORTH. The shares of stock in KREMSER WRIGHT RD., INC. are owned by the same shareholders that own the outstanding stock in KREMSER SALERNO RD., INC., a Florida corporation, the General Partner of THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH. The two corporate General Partners are merging with KREMSER SALERNO RD., INC. as the surviving entity. The surviving corporate entity will remain the General Partner of the surviving Limited Partnership.
- 3. THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH will file an Amended Certificate of Limited Partnership reflecting a name change of the Partnership to "KREMSER FAMILY LIMITED PARTNERSHIP". The Certificate will also reflect that the corporate General Partner has changed its name to KREMSER MANAGEMENT, INC.
- 4. This Plan of Merger between THE KREMSER FAMILY LIMITED. PARTNERSHIP NORTH and THE KREMSER FAMILY LIMITED PARTNERSHIP SOUTH was approved by the unanimous written consent of the Limited Partners of each Limited Partnership and by the General Partner of each Limited Partnership. KREMSER MANAGEMENT, INC. formerly known as KREMSER SALERNO RD., INC. has, by written consent, agreed to continue to serve as General Partner of the merged surviving Limited Partnership.
