The total amount of the capital contributions of the limited partners is \$69,651.

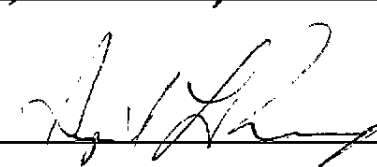
