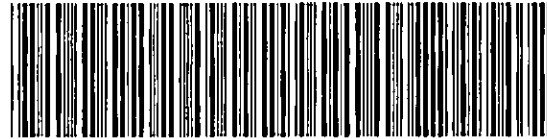

5. **Termination.** The limited partnership has a perpetual duration.


The effective date of this Certificate of Amendment shall be the date of filing with the Florida Department of State Division of Corporations.
