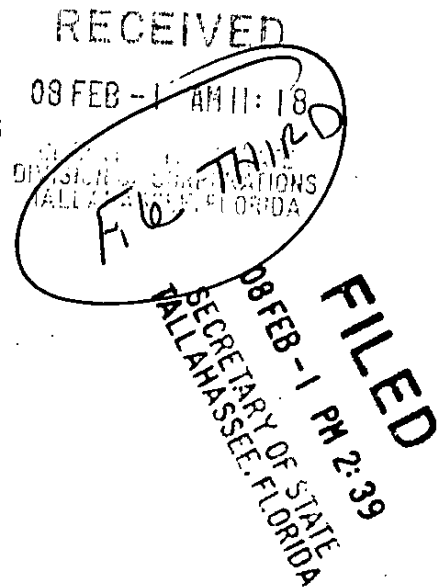


WELCH INVESTMENTS OF SARASOTA, LTD.
