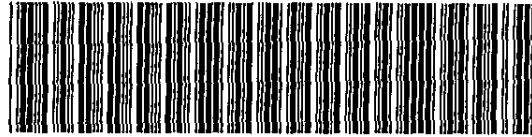

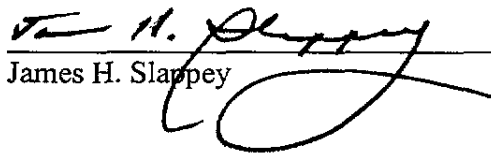
1. The name of the limited partnership is JBJ Resources, Ltd. (the "Partnership").
