This Certificate of Amendment, is executed as of the 10th day of October, 1997, by Florida Hospital Waterman Ambulatory Services, a division of Florida Hospital Waterman, Inc., a Florida not-for-profit corporation, as General Partner of FLORIDA HOSPITAL WATERMAN AMBULATORY SURGERY CENTER, LTD., a Florida limited partnership (the "Partnership"). The purpose of the this Certificate of Amendment is to acknowledge the withdrawal of the Original Limited Partner from the Partnership and to enumerate those additional Limited Partners which have been admitted to the Partnership.

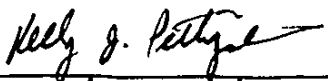

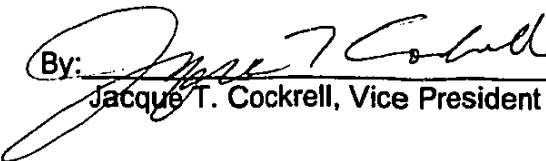
